

**Hillels of the Florida Suncoast
Jewish Life Festival Chance Drawing**

The Jewish Life Festival (“Event”) Chance Drawing (“Chance Drawing”) is a volunteer-based program conducted by Hillel Jewish Student Center of Tampa, Inc. (“Hillel” and/or “Sponsor”) in support of its mission to be engage and empower Jewish college students through educational, social, cultural, religious, Tzedek, Israel and leadership programs. These rules (the “Rules”) apply to all participants. The Sponsor will make all determinations as to whether the Rules have been complied with, and the decision of the Sponsor as to any issue is final.

Sponsor: Hillel is the Sponsor of this Chance Drawing.

Eligibility: No purchase or donation is necessary to participate in the Chance Drawing. Participation is open only to legal residents of the 50 United States or the District of Columbia who are 21 years of age or older as of the date of entry who are attending the Event. Employees of Hillel and their immediate family members and Hillel students are not eligible to win.

For this purpose, “immediate family” includes the spouse, parents, grandparents, great-grandparents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This definition also includes a) “step” and adoptive relationships, b) individuals for whom an employee is the current legal guardian and c) individuals who are not legally related but who reside with an employee. THE CHANCE DRAWING IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Entry: Participants can enter the Chance Drawing during the Chance Drawing Period by visiting www.suncoasthillels.org/jewish-life-festival-chance-drawing.

Limit 10 entries per person.

Time: The Chance Drawing starts at 8 a.m. (all times Eastern Time) on October 17, 2022 and ends at 3 p.m. on November 13, 2022 (the “Chance Drawing Period”). All entries must be received by Hillel during the Chance Drawing Period.

Prize(s): The Chance Drawing Prize includes a 14-karat yellow/white gold Star of David pendant with a 20" yellow gold chain, a \$100 Gold & Diamond Source Gift Card, a \$150 Capital Grille Gift Card, a \$50 Uber Gift Card, two (2) Bottles of Fine Wine, and a box of William Dean Custom Chocolates.

The actual values may be more or less. The odds of winning are dependent on the number of entries.

Determination of Winner: There will be 1 winner (the “Winner”) of the Chance Drawing. The Winner will be notified by Hillel either by phone call or email following the determination. The selection of the Winner by Sponsor is final and binding on all participants.

Taxes: The value of the Prize is includible in the Winner’s income. Sponsor may be required to report the value of a Prize to the Internal Revenue Service. A Winner is responsible for paying all federal, state, and local income and other applicable taxes due in connection with receipt of a Prize, if any.

Consent to Publicity. By entering the Chance Drawing, the Winner consents to Sponsor’s use of the Winner’s name, voice, likeness, Social media handles (including but not limited to Twitter, Instagram, and TikTok) and/or photograph in any publicity, publications, promotional and marketing material, advertising, and any other print materials, web pages, electronic or other communications published or distributed by Hillel without compensation and without notice and agrees to sign an agreement to this effect.

Miscellaneous Conditions: In the event that the operation or administration of the Chance Drawing is impaired or prevented in any way for any reason, including, but not limited to fraud, change of condition, or other technical problems, the Sponsor may in its sole discretion, either: (a) terminate the Chance Drawing; (b) suspend the Chance Drawing to address the impairment and then resume the Chance Drawing in a manner that best conforms to the spirit of these Rules; and/or (c) substitute other prizes for any prize set forth in these Rules that becomes unavailable for any reason. The Sponsor reserves the right in its sole discretion to disqualify any individual found to be tampering with the entry process or the operation of the Chance Drawing or acting in violation of these Rules. Failure to execute and return the Winner Notification Agreement and accept a prize, timely, and pursuant to the terms stated therein, will result in such Winner's automatic forfeiture of Winner's prize with no substitution or alternative prize available.

Sponsor is not responsible for: (i) electronic transmissions that are lost, late, stolen, incomplete, damaged or misdirected; (ii) any problems or technical malfunctions, errors, omissions, deletions, defects, communication failures or (iii) causes beyond the Sponsor's reasonable control that jeopardize the administration, security, fairness, integrity or proper conduct of the Chance Drawing. Sponsor makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning the Prize (or any other prize) furnished in connection with the Chance Drawing. By participating in the Chance Drawing, participants agree to release, discharge and hold harmless Sponsor, its directors, officers, employees, and agents from and against any and all injuries, claims, losses, damages, actions and/or liability arising out of or in connection with, directly or indirectly, participation in and/or entry into the Chance Drawing or acceptance, delivery, possession, use or misuse of a Prize (or any prize) received in this Chance Drawing.

The determinations of Sponsor are final and binding with respect to any matter arising out of the interpretation or application of these terms and conditions.
